An area of concern to the Cape has reared its ugly head with regard to school capacity guidelines. As you know, the Broadneck High school feeder system has been over capacity for some time resulting in a moratorium on new construction other than for senior subdivisions. The County Council is considering revamping the formula for judging capacity. The reasoning is bizarre. The theory is to deliberately over crowd the schools by lifting the building moratorium, allowing construction to boom again on the Broadneck Peninsula, and assume that the state will direct more funding for school construction ect. to AA county! Do these people have any grasp of reality? There are 2 portables at Cape elementary now; how many more can we look forward to? We have a premier high school, overcrowding will make that harder to maintain. The most severe ramification for Cape will be the development of College Parkway where all of the adjacent land is already slated for subdivisions, but has been idle because of the school capacity moratorium. Lifting that building moratorium will result in a rush to construct family homes as soon as possible no matter what the condition of the housing market. Just imagine College Pkwy with hundreds of more

cars traversing it daily, ove crowded schools, more backups on RT 50, all impacting our quality of life in the worst way. Who benefits from this madness? Not your community, but a few developers with the right connections, and some politicians with dubious intentions. pleasure with the County's stated effort to take part of the Goshen Farm property for soccer fields: Reported that Mr. Jim Schroll, County Department of Roads Engineering, held a meeting concerning the Cape St. Claire Road Improvement Project. Mr. Schroll provided status on the project, including plans for a traffic light at the Cape St. Claire Road/Hilltop Drive intersection, and right-of-way problems with the shopping center parking lot. President Gardner commented that she would send Mr. Schroll a letter stating that a traffic circle is preferred to a traffic light, and to state that any right-ofway issues with the shopping center parking lot property should be directed to the CSCIA, as it owns this property.

Minutes and Financials:

Motions were made to approve the February 11, 2008 Monthly BOG Meeting Minutes and the January 31, 2008 Financials. These motions were seconded and unanimously approved.

Agenda Item:

A Cape resident was provided an opportunity to address the Board concerning potential uses of the community signboard beyond the norm. After listening to the resident's recommendations and discussing their pros and cons, the Board generally disagreed with the recommendations, but agreed to give them additional consideration.

Committee Reports:

<u>Piers</u> – Governor Gallagher reported that of the 205 boat slip rental contracts recently mailed out, only 21 contracts have not been received back.

Membership – Governor Pollock noted that the next Quarterly Membership meeting is scheduled for April 22, 2008. Clubhouse – Governor Lamb stated that the double-doors on the water side of the clubhouse need to be replaced because the current doors are rotting out.

Beaches and Parks – Governor Newman reported that the dinghy racks at Lake Claire would be moved in order to improve the water view; that an erosion problem at the Little Magothy area was completed using a rock swale. He is working on a plan to possibly install parking gates with card sensors at the Deep Creek and Lake Claire areas. Physical placement, administrative questions and other issues related to such a project are still being evaluated as part of the plan.

Agenda Item:

Residents owning a home in the vicinity of the Southview Drive

and Chestnut Tree Drive intersection were provided an opportunity to address the Board concerning problems they are experiencing with Broadneck High School students near their home Discussion included:

- Large numbers of students congregate on or near their property before, during and after school causing problems, which have gotten worse with time.
- 40-50 students standing around, smoking, dropping large amounts of debris including prescription drug bottles, destroying property, fighting, intimidating the crossing guard and harassing other students having to go around in an effort to get to the school.
- Over an extended period of time these residents have placed trashcans in the area, posted

"No Trespassing" signs and called police – all to no avail.

- They have requested meetings with the high school principal, but received no response. After another request, the assistant principal agreed to try to meet with them soon.
- The residents wanted the CSCIA to be aware of these problems and asked for CSCIA assistance and support in trying to get some resolution.

President Gardner agreed to provide the resident with a letter of CSCIA support to present at their upcoming meeting with the assistant principal.

Adjournment: The regular March 10, 2008 BOG Monthly meeting ended at 9:10 p.m. The next monthly Board of Governors meeting is scheduled for April 14, 2008 at 7:30 PM.



Spring Rains Bring the Need for Storm Drains

Anne Arundel County continues its efforts to address the effect of stormwater run-off, retrofitting and replacement of failing culvert and drain systems. With spring quickly approaching (although as I write this, they are calling for storms and snow showers), it seemed appropriate to give you an update on Bill 85-07, the property tax credit available for retrofitting existing properties with stormwater best management practices.

After the unanimous passage of the bill (many thanks to my colleagues for supporting my legislation), the Planning and Zoning Office got to work analyzing the types of property enhancements which would qualify a property owner for a tax credit. The preliminary list is a short one, while Planning and Zoning evaluates the more detailed techniques that might require professional engineering. Immediate qualifying benefits include: (1) the removal of twenty percent of existing impervious surface on your property. This could be anything from converting an existing sidewalk or driveway made of concrete or asphalt to one made of pervious material such as "crush and run" or oyster shells, rock or gravel; (2) rain barrels. Perhaps the easiest and least expensive to install, rain barrels have an enormous positive impact. As roof run-off is captured by barrels attached to the end of down spouts, water can be stored for later use; (3) any other pre-manufactured best management practices that the Maryland Department of the Environment (MDE) approves. Techniques such as undergroud piping, cisterns and bay saver devices, where practical, can be installed as qualifying for the credit.

The goal of Bill 85-07 was to have financially affordable products and improvements that residents as well as businesses could install. Over the coming months, Planning and Zoning officials will evaluate other techniques such as rain gardens, green roofs,

permeable pavers and synthetic turf. I anticipate being able to add to the list, bioswales between curbs and streets and parking lots developed in conjunction with permeable pavers.

Recently, I had an opportunity to participate in a seminar with the Environmental Protection
Agency and representatives from Pennsylvania and Virginia who are also looking at ways to address aging stormwater problems. It appears there is national interest in our hometown solution to stormwater management. I look forward to sharing our successes of our program with the rest of the county.

If you are working on your property and interested in applying for the credit, I urge you to contact the Office of Finance, Tax Billing Manager, for an application.

I urge our community to be among the first to implement property retrofits and reduce stormwater runoff.

Hello Fellow Capers! Happy Spring!

On a recent Friday night, we thought we would try Greystone Grill, which opened last October, located in the Severn Savings Bank on Westgate Circle (across from the new Westin, on the traffic circle). 200 Westgate Circle, Annapolis, MD 21401 (410) 349-5052, www.greystonegrill.com. The first thing we learned is that despite the fact that they have free on-site parking, it isn't suited for large or even medium sized vehicles. In fact, we observed the parking attendants getting a good laugh at customers' expense, as they watched many attempts of people trying to negotiate the tight corners and parking spaces in the garage. If you go, we recommend traveling by burro. Once we got inside the building, we found that the atmosphere really felt like what it is, a bank, not a restaurant. A little nervous about what we were getting into. we decided to try a drink and appetizer at the bar before committing to a full blown meal at Greystone. The bar had all the appeal

of Ramada Inn lounge bar serving half priced afterchurch cocktails. The bartender was a huge man who was difficult to understand. Kathleen asked for a glass of Zinfandel wine and he replied, "Which one?" But there was only one on the menu. Ben ordered a Budweiser. Nope, they don't carry those. Bud Light for him. We ordered the "Cracked Lobster and Seafood Cocktail," advertised as; "Lobster, shrimp and jumbo lump crab, chilled, with a gazpacho sauce, avocado and lime (Great to share!)" We found it over-cooked, overpriced and underflavored. We had to look under a ton of leafy green things to find anything resembling seafood. The "gazpacho" sauce was blander than play-doh. Ben described the whole Grevstone Grill bar atmosphere as a true death row experience; much like Tony Soprano having his out of body Kevin Finnity experience, we kept thinking it was all a bad dream and we would eventually wake up. In short, our recommendation is don't waste vour time or money here. We vacated the Greystone Grill like a couple of

gees wondering what replacement restaurants we could find available in Annapolis on a busy Friday night.

We ended up at one of our favorite places, The Rockfish, in Eastport at 400 Sixth Street Annapolis, MD 21403, (410) 267-1800, www.rockfishmd.com. What a gem! The bar area was very busy, and is pleasantly decorated. We were seated quickly in a comfortable large booth in the dining room. We had wonderful service from Nikki. We've eaten here many times and have always enjoyed the experience. Coming to Rockfish feels like seeing an old friend with whom you still have something in common; comfortable, enjoyable, relaxing. Quiet, well decorated dining room, attentive service from informed and professional wait staff. We recommend the Flat Iron Steak. The steak was tender with a spicy southwest seasoning. Possibly a touch salty, but still excellent. We also recommend the crab cakes, salmon, burgers and seafood Cobb salad. Be sure to try the delicious corn pudding and potatoes au gratin side dishes; good size to share. Dinner entrée prices range from \$19 -\$30. They also have a Sunday live jazz brunch. On another trip to Rockfish, a group of twelve

ladies had a fun night out during Restaurant Week. The salmon and Rockfish salad got lots of praise. We had great service, which can sometimes be hard to pull off with such a large group. The Rockfish isn't flawless, but is consistently good, particularly for its price range. And with free on site parking (which accommodates all manner of vehicle types and sizes, as well as burros), it's a good pick.

On a recent Sunday afternoon, we worked up quite an appetite after walking our dogs all over beautiful Ouiet Waters Park and headed over to the Mexican Café for a late lunch/early dinner. 975 Bay Ridge Road, Annapolis, (410) 626.1520. The menu has so many great sounding options, we had a hard time deciding what we wanted to order! Definitely come hungry, because the servings are large enough for breakfast, lunch and dinner combined! And the margaritas are quite stout and reasonably priced. We started with the Texas chile con queso dip which was very good, served with their homemade corn tortilla chips. The salsa is also very good, flavorful, but not too spicy. Kathleen was pleased to see so many vegetarian options on the menu. They also serve Mexican breakfast all day long, if that's

what you are in to. Ben ordered the "My Favorite Combo," which was a four item combination plate including one of Ben's favorites, cheese enchiladas. Kathleen ordered the Southwest grilled veggie quesadilla, which came with black beans and very yummy guacamole. The atmosphere is casual, cozy and friendly. Consider eating outside on the front porch. Service was attentive and speedy. Prices are very reasonable; selections range from \$7.50 for salads and starters to \$15 for entrees for hearty appetites. The atmosphere is family friendly, and fun. As one reviewer from Trip Advisor wrote; "It looks like an off the wall back alley place to eat, but it is well worth stopping in and enjoying the food." This is as good as Mexican food gets in Annapolis!

Ben's pick for beer of the month: DuClaw Hop Devil Ale. 7000 Arundel Mills Circle, Hanover MD.

www.duclaw.com. This beer is a pleasant accompaniment of hops, with the faintest hint of smokiness and even trace of grapefruit. Sadly, DuClaw has stopped brewing their Venom Ale, but the Hop Devil is a pretty good sub-

stitute. DuClaw also serves great burgers!

Recipe: Mean Kathleen's Crab Dip

1 c. shredded cheddar cheese
1 lb. back fin crab meat (picked through)
12 oz. softened cream cheese
1 1/2 c. sour cream
1 T Worcestershire sauce
1 T Creole mustard
Juice from ½ a lemon
Couple shakes of garlic pepper
Couple shakes of Old Bay seasoning

Combine all ingredients except crab meat and ½ cup cheddar cheese. Gently add crab and combine. Put mixture into a baking dish and top with remaining cheddar cheese. Bake at 350 degrees until; cheese looks bubbly. Serve with crackers and toasted baguettes. Enjoy!

Transplanted: A Caper Overseas By Audrey Lengbeyer

Ah, is it April already? Surely the daffodils are blooming in the Cape, and how I miss my garden! When spring comes, I am usually dying to get outside, to push seeds into the earth, to pull dead leaves away from the new shoots, to start the composter spinning again. It's an outlet, I think, for the same energy in me that pushes those shoots up from the earth – spring is a season when everything feels fresh and new and full of possibility.

Here spring has sprung, and the air is full of the delightful sound of birds chirping. The sun shines, the sky is blue, plants are bursting out with buds and new shoots, blanketed with flowers. We've taken the girls many times to the beach already, and they've even gone wading and splashing into the water. One day it was in the 80s already, a fluke, but lovely nonetheless! In five days, my parents arrive for a 2-week visit. The kids are unbelievably excited – the older one has a chart on the wall counting down the days until their arrival. We are excited but also a bit anxious – it's always a challenge to have one's parents around

for such a long period, even if they are staying in a bed and breakfast nearby.

As our time here draws to a close (only 3 more months before we depart for a month in Europe, and then home), we find ourselves starting to think about reentry to Annapolis. Our sabbatical year is nearly over, and I've had many thoughts about what this year has meant to us. Of course for Larry, it's been a break from the grind, of teaching at the Naval Academy, of his administrative responsibilities serving on various committees and in his own department. He hasn't worn a tie all year long, and has gone to work in shorts – he loves that part. It's been a time where he's been free to do more reading and writing, and to rediscover the ideas that stimulated him to begin teaching philosophy in the first

place, though he feels as if he's barely gotten to do these, having spent all of his time instead finding playgrounds and Englishspeaking friends for the girls, finding a rental car and Internet service, figuring out the heating system and setting up the DVD player, and all the other nonsense that comes with a big move. He's also spent a lot of time getting to know his colleagues, and traveling the country with us.

For the rest of us. it's been less clear what this year might be. It was when speaking with the husband of one of Larry's fellow Fulbright scholars here in Israel that I began to see that sabbaticals might serve deeper purposes. This couple, we'll call them Dana and Michael, are both doctors. Dana is the Fulbright scholar, working with local Palestinian and Israeli doctors on reducing domestic abuse in Israel and the West Bank. Michael was an overworked ER doctor, and told us openly about his wanting to use this year to contemplate his career options. Instead of practicing here, he's been attending ul-

pan, or Hebrew immersion school, and volunteering at a local homeless shelter. His mind, he told us, was finally away from his work, and thinking about it, he really didn't want to go back to his old workaholic life upon his return to New York. Talking with him made me realize what a unique and special opportunity a sabbatical is - not just a chance to experience a different life for a year, but a chance to use that time to reflect upon one's life, and to change that life. What do we miss about our normal life? What are we glad to be away from? What would we rather be doing when we go back?

I've also found myself several times telling myself, "oh well, it's only temporary." So we only have four towels, so we don't have enough area rugs. So we only have one cookie pan and no muffin tin. If we were home, I would deal with these problems, mostly by going to Bed Bath and Beyond. Here, I think, why bother, we can live without those things for a year. I've even found that I've been much more flexible as we've made friends, knowing it was nothing permanent, just enjoying the moment or the day, without much thought of compatibility. Why bother? We're leaving anyway. But as I've thought more about it. I've realized that everything in life is temporary, just to different degrees. Ultimately, life itself is a temporary state of affairs, and we really have no way of knowing just how temporary. How liberating to focus on enjoying a new friend in the moment, without evaluating, without predicting. Perhaps I can bring back that sense of living in the present to my more permanent life in Cape St. Claire. Because we have only a year here

to enjoy Israel, we've been making a lot of effort to see the country and enjoy its treasures. This made me realize that we often experience more richly the places we travel than the place we live. What if we only had one year to spend in Maryland? How much more often we would make the drive to see the free museums and monuments in DC, or go crabbing off a pier, or walk through the woods for an outdoor concert at Quiet Waters? How much more would we have ice cream down at City Dock, go canoeing in the Chesapeake watershed, take a picnic under the cherry blossoms at the Jefferson Memorial? Having a sabbatical has not just been a year off; it's helped me to reframe what it is to savor a day when one only has 365 of them – and I hope to remember that as we reenter life in our cher-

ished Cape St. Claire.

So I've tried to take a sabbatical too. I've spent a day a week hiding awav in a café. away from my mothering responsibilities. I spend the time reading, writing, and knitting. One day I even drove down to the beach boardwalk and went running for the first time in vears in a brand new pair of running shoes. (Boy was I sore

the next couple of days, and for my next run!) It's been delightful to have these moments to myself, and I hope also to remember to carve out this time for myself when we get home. In our normal lives, it's so easy to put things off, to say I can wait for another time to pamper myself, go see the sights, do something special. Here, it's been much easier to have those higher on the priority list. My hopes for our post-sabbatical life is that we can retain the sense of living more for today, the sense that each day is precious because it'll soon be our

Ultimately, our sabbatical has reminded me that one day our gig is up. And we can never really know when. Carpe diem!
