

#### MEMBERSHIP MEETING January 10th, 7:30pm Clubhouse

At all meetings of the Association, the presence of 25 members shall be necessary to constitute a quorum. If there are insufficient members present to establish a quorum at the time a membership meeting is to be held, a substitute meeting may be called under the following procedure:

- A. A majority of the members present calls for the substitute meeting. Then,
- B. The presiding officer shall set a date falling within 30 days for a substitute meeting of members; and
- C. Notice of this substitute meeting shall be given 10 days or more in advance to all members of the Association, and shall include the following information;
  1. the time, place and purpose of the meeting; and
  - 2. a statement explaining that at the substitute meeting the members present constitute a quorum.
- All absentee published ballots not counted for lack of a quorum at a membership meeting shall be counted at the substitute meeting.

#### **BOARD IN BRIEF**

November 14, 2011

The November 2011 CSCIA Monthly Board of Governors meeting was convened on November 14, 2011 at 7:33 P.M. in the Cape St. Claire Clubhouse, Cox Meeting Room.

President's Remarks: Vice President Mooneyhan had no opening remarks other than to introduce Jennifer Wiles of BB&T Insurance Services. Ms Wiles presented the board with the results of BB&T's analysis of CSCIA's current insurance policy. She stated that the current policy is less expensive than comparable offers and was generally a very good policy. Ms Wiles stated that BB&T Insurance Services could provide riders for additional coverage if needed.

Minutes and Profit and Loss Statements (P&Ls):

September 12, 2011 CSCIA Monthly BOG meeting minutes: Governor Newman made a motion to approve the minutes. Governor Lamb seconded the motion and it was unanimously approved.

August 31, 2011 and September 30, 2011 Profit and Loss Statements (P&Ls): Governor Newman made a motion to approve the P&Ls. Governor Daly seconded the motion and it was unanimously approved.

#### **COMMITTEE REPORTS:**

Clubhouse: Governor Lamb reported that the storm door to the Cox Meeting Room had been replaced, and that she is obtaining estimates to replace the Clubhouse roof.

Caper: Governor Lamb reported

that the Caper was doing well but that this month's issue was going to be somewhat late as they had been waiting for budget information to be included.

Signboard: Governor Lamb reported that the signboard and the letters are in bad shape. She has spoken to the fire department relative to a shared signboard. Governor Lamb made a motion that the CSCIA formally approach the CSC Volunteer Fire

Department and discuss the feasibility of a joint sign in front of the firehouse. Governor Newman seconded the motion and it was unanimously approved.

**Treasurer:** Governor Newman distributed documentation explaining the budget process, the areas of expenses and revenues, and the process of submitting the budget to the county. There was some discussion regarding assessments and caps.

Beaches and Parks: Governor Newman reported that there had been occasional complaints about the towing policy and that all complaints have the option for appeal. The first and only appeal was presented to the Board regarding a contractor's vehicle that had been towed while he was working on a resident's boat.

Covenants: Governor Daly reported that there had been an anonymous complaint of a boardinghouse in the Cape. He noted that unless neighbors are willing to come forward with specifics, the BOG and/or the county are unable to properly respond as evidence is needed.

Roads: Governor Dembowski reported that, as he stated at the quarterly meeting, construction on Cape St. Claire Road will probably not begin until midsummer 2012. Contracts are scheduled to be distributed in January.

#### **OLD BUSINESS:**

Governors Mooneyhan, Newman, and Daly stated that they had old business which needed to be discussed in closed session.

#### **NEW BUSINESS:**

Governor Daly commented that, in view of the towing policy, Beaches and Parks needed to let slip renters know that contractors working on their boats needed some sort of signage to prevent being towed.

#### **COMMENTS:**

A resident stated that he was formally withdrawing his request to be reimbursed for the removal of a CSCIA tree that fell on his property during storm Lee. The resident expressed his concerns about the remaining large stump and hole in the ground on the easement behind his property, stating it was an eyesore and a possible danger.

**Adjournment:** Governor Newman made a motion to adjourn

from the regular monthly meeting and enter into a Closed Session meeting. Governor Daly seconded the motion and it was unanimously approved. The regular November 14, 2011 CSCIA Monthly BOG meeting was adjourned at 8:30 P.M.

**Closed Session Meeting:** For the purposes of addressing legal issues, a Closed Session meeting was convened at 8:35 P.M. and adjourned at 9:05 P.M.

Attendance: Governors Daly, Dembowski, Lamb, Mooneyhan, and Newman were present. Governors Campbell, Gallagher, and Gardner were absent. Budget Committee Chairman Buchet was also present.





#### PROPOSED FY2013 **SCBD BUDGET**

Each year the Budget Committee develops a consolidated budget for the Cape St. Claire Improvement Association, Inc. (CSCIA). The Budget Committee is composed of up to three committee members elected by the community and two members appointed by CSCIA Board of Governors (BOG), usually the President and Treasurer. Once completed, the budget is presented to the Board of Governors for review, comment, and approval. The proposed SCBD budget included in this issue of The Caper has been reviewed by the BOG and recom-

mended for approval by the CSCIA membership. In accordance with our charter as a Special Community Benefit District, SCBD funds may only be expended to meet the four major purposes for which the SCBD was created:

> Maintenance of community property (beaches and parks, playground equipment, and the fishing pier);

Special security for community property;

Acquisition, improvement and construction of real and personal property (such as the Clubhouse);

Administrative expenses incidental to carrying out these functions.

These functions and the associated budget totals are listed on the proposed budget summary sheet



Happy Holidays to all our fellow Cape residents!

The Garden Club welcomed several new members in October and November, while the mums were filling our gardens with autumnal color, and hopes to see even more new faces at our next meetings!

On Tuesday, January 3<sup>rd</sup>, at 7pm, we'll have our 2<sup>nd</sup> Winter Sowing Workshop. You can germinate seeds, without doing a thing – no grow lights, no fussing, no sunny window boxes! Attendees bring clear plastic containers like milk jugs, boxes (with lids) from spinach or lettuce, soda bottles, and the like. The Club provides sterile seed-starting medium and a variety of vegetable

and perennial seeds. We'll each fill our boxes, take them home, and and the county, are in process. place them outside in a sunny spot. By March, most of us will find our boxes full of tiny green seedlings! Anyone is welcome to join us and participate. Please bring a few containers of your own and come join the fun!

On Tuesday, February 7<sup>th</sup>, at 7pm, we plan to have another speaker on rain gardens, special beds of plantings designed to collect the run off during big rains. Do you have water run-off on your property when it rains? Many folks in the hilly Cape do, and it's an ongoing process finding a solution. At our last meeting, we had yet another discussion from some of our newest members about the work being done by the Master Watershed Stewards, some of whom live and volunteer right in this community. #### **Oyster Nursery News**

We're a little nervous this year, as are the oysters. We recently sent all the baby oysters, so carefully raised by all the local volunteers, on their way out to the restoration reef. We had so much crazy weather this summer! All that storm water caused a serious drop in salinity, an incredible amount of debris, and extremely murky waters. Oysters need a certain amount of salinity to survive, and some recent reports say many of them have perished. Dick Carey, who heads up our trusty dive team from the Magothy River Association will visit the reef in person this spring, and tell us the good news or the bad news, so cross your fingers.

There was plenty of excitement this year, because the one year old oysters grew very well. This year was a bountiful year for algae and sediment too, so it kept us busy. We had dozens of new oyster growers come to the nursery to pick up their cages and spat, so we welcome them all to the Maryland Grows Oysters program. If you'd like to participate next year, feel free to email us, the address is in the sign board at the nursery. There is no cost, and only a half hour or so a week in care required. You do need a pier, either yours or maybe a friend's, but a community pier will not suffice.

Meanwhile, a new generation of tiny spat on shell is spending the winter in cages hung from local piers, with hopes of renewing their population. The bumper crop from our Cape Oyster Nursery went out to the reef with the others, and we've hung the newborns in cages for the winter as well. We had a great year, with a lot of help from our friends. Rick Danforth, Rene Burgan, Bridgette Presti, Doug and Madam Tsitouris and Brad Knopf all pitched in to clean and maintain the nursery. We would never make it through a year without Greg Young with his plumbing skills and watchful eye. Please stop by and see the nursery, and if you'd like to volunteer, we could use the help and we'd love to have you join us.

Bay-Wise Landscape Management. With this program, homeowners can learn how to maintain a healthy landscape. Conserving water, minimizing runoff, composting, controlling pet waste, and eliminating erosion can earn you Bay Wise certification. You'll see one of the iconic blue "Bay Wise" signs by the Salam's driveway.

Catherine's yard is a wealth of environmentally friendly features. There are five rain barrels to make sure all downspout water is put to good use. A series of bins and stations for the various stages of composting are located strategically around the property, to ensure no clippings, branches, scraps or leaves are wasted. A copper tubing drip irrigation system is in place for the raised vegetable garden plots in the back yard.

The edges and down slope borders of the property are buffered by absorbent gardens, filled with hundreds of native plants, edibles for both table and wildlife, as well as ornamentals. Oak Leaf Hydrangea, Woodland Poppy, Maple Leaf Viburnum, Coreopsis Tick Seed, Yellow Flag Iris, and Red Twig Dogwood begin the parade. Rare Pitcher plants grace the idyllic stone lined pool in the front yard. Cornus Florida, Late Winter Blooming Witch Hazel, "Fireworks" Goldenrod, "Flame" Azaleas, Red Bud and Beauty Berry turn the corner toward the side yard, with its pervious stone paved walkways. Late Blooming Rudbeckia, Helianthus Augustafolia, and Rosa Rugosa dress up the back yard, with its graceful stone benches and statuary. Along with the vegetable gardens, the feast of figs, blueberries and strawberries make a fine dessert!

#### Councilman Dick Ladd Anne Arundel County Council Fifth District

November Article

The Council is now about half way through considering the comprehensive rezoning of Districts 2, 3 and 5. For District 5, Planning and Zoning (P&Z) recommended 17 changes of which 10 were in Severna Park and 7 in the lower Broadneck peninsula.

In general, the District 5 changes reflect the mature, built-up nature of Severna Park and deal mainly with "in-fill" issues and recognition of approved businesses that have been operating on "nonconforming variances" for long periods of time. The biggest development proposed is for the expansion of the small shopping facility on the northeast corner of Earleigh Heights Road and

Ritchie Highway in District 3.

For District 5 in Severna Park, P&Z recommended five upzonings on Route 2 providing, for the most part, the appropriate commercial zoning for several, long-standing businesses (Rey's Crab House, the Harms property, the Great American Car Wash, Pete's Cycle and the property located at 8300 Ritchie Highway).

Along the Severn River, two boatyards were given "marina" status (Forked Creek Yacht Club and the former Sappington's Marina).

A requested change for commercial zoning to develop a large, new 55+ housing complex on Jumpers Hole Road near Severna Park Middle School (the Blanchfield property) was denied by P&Z but otherwise up-zoned to R5. An amendment request to increase the R5 zoning to R10 or R15 remains under review.

I have or will suggest at least five amendments for Severna Park. Two are for limited up-zoning to support existing Route 2 businesses to accommodate their growth-related plans (Moscker Insurance and Chappell).

Three amendments pertain to the east side of the Veterans Highway corridor: One change restores residential zoning where a commercial upgrade was recommended by P&Z (Curtis). The second up-zones two contiguous lots at the corner of Veterans Highway and Brightview Road to medium density residential (R10). The third provides appropriate commercial zoning for the long-standing service station

(Williams) at the corner of Veterans Highway and West Benfield Road to support their revitalization plans.

In Arnold and the Broadneck area, two boatyards (Belvedere and Whitehall Yacht Club) were given "marina" status.

Along Route 2, the Jordan property will be proposed for commercial zoning to match the General Development Plan land use prescription. The Forthofer property (otherwise known as the Honeysuckle Consignment Shop) is proposed for a slight increase in zoning to support a small increase in parking space. At the Arnold/Route 2 intersection, P&Z recommended commercial zoning at the southwest corner (Shavitz), eliminating the existing commercial/residential split zoning.

Another split-zoned property (the lot behind the bakery on St. Margaret's Road) was recommended to be up-zoned to commercial. However, I have proposed an amendment to delete this change.

Two properties on College Parkway adjacent to the Anne Arundel Community College (FutureCare and the College Parkway Baptist Church) were upzoned by P&Z to R5.

The shopping area on eastbound Route 50 near the Bay Bridge is designated for revitalization. To that end, P&Z proposed commercial zoning for a small undeveloped lot on the service road (Singleton). I have offered an amendment to increase the zoning level of the shopping center from C3 to C4 to support redevelopment efforts.

All of these steps were taken after careful consideration of the views of the Severna Park Chamber of Commerce, the Greater Severna Park Council, the Broadneck Council of Communities, and many other organizations and community members including the "omni-present" Al Johnston, whom we wish a very speedy recovery from his recent surgery.

One final note – I would like to hear from anyone who may be interested and willing to serve on the Animal Control Board starting in January 2012. This is an unpaid, two-year position appointed by the County Executive. (Members can serve no more than two consecutive terms.)
