### **BOARD IN BRIEF**

CSCIA BOARD OF GOVERNORS MONTHLY MEETING **APRIL 11, 2011** 

The April 2011 CSCIA Monthly Board of Governors meeting was convened on April 11, 2011 at 7:30 P.M. in the Cape St. Claire Clubhouse, Cox Meeting Room.

**President's Remarks:** President Gallagher presented the agenda for the meeting and made brief opening remarks, including:

Council member Dick Ladd will attend the April 26<sup>th</sup> CSCIA Quarterly Membership meeting.

Welcomed Dr. Bruce Campbell back as a CSCIA
Board member and assigned him to chair the
Membership Committee.

### Minutes and Profit & Loss Statements (P&Ls):

A motion was made and approved to accept the Minutes of the February 14, 2011 CSCIA Monthly BOG meeting. A motion was made and approved to accept the amended March 14 CSCIA Monthly BOG meeting minutes. A motion was made and approved to accept the February 28, 2011 Profit & Loss Statements.

### **COMMITTEE REPORTS:**

Roads: Governor Dembowski reported that repaving work on Hampton Road should be completed by next week. He also repainted the "Welcome to Cape St. Claire" sign on Green Holly Drive and commented that this sign will soon need replacement due to age.

Building: Governor Mooneyhan reported that she issued two stop-work orders on construction projects. Also, in an effort to ensure proper CSCIA insurance coverage at the best possible cost, she continues to work on determining communityproperty replacement costs and will get cost estimates from our current insurance carrier and possibly other brokers.

Pat and Danny Miller: Proprietors of the River Bay Roadhouse restaurant in the Cape Shopping Center were provided an opportunity to address the Board of Governors to seek approval for a drive-thru window on the side of their building, between them and the Bank of Annapolis. If approved, this drive-thru window would only be open in the evening hours after the Bank closes and on weekends. ... After lengthy Board discussion, including liability

issues, required signage enhancements, customer conveniences, traffic concerns, the drive-thru window located on the passenger side of the vehicles, and other related subjects...a motion was made and approved to allow the River Bay Roadhouse to have a drive-thru window for a 6-month trial period.

Beaches and Parks: Governor Newman reported a tree-cutting issue at the Deep Creek pier area that for legal reasons would require a Closed Session meeting after the regular Board meeting.

**Caper:** Governor Lamb reported that an improved process of addressing the Caper has resulted in a better delivery of the Caper and at a cheaper cost.

Piers: President Gallagher reported that a 40' to 60' section of pilings at the Deep Creek area will soon need to be replaced, along with some pilings at the Lake Claire pier. He also reported that the Deep Creek slips are booked, so the only slip moves will be at Lake Claire and Little Magothy pier areas.

### **OLD BUSINESS:**

Governor Newman reported that he continues to work with the Department of Natural Resources to research solutions to the Lake Claire beach erosion control issue, including shoreline stabilization efforts and a possible zero percent loan opportunity if we become an SECD (Shore Erosion Control District). He distributed several



### Goshen Farm Preservation Society

Did You Know?

Henry Woolchurch was the original "owner" of the land that eventually came to be known as Goshen Farm. He was among the first to arrive from Virginia and settle in Providence on Greenbury Point, as evidenced in James Ehlen Moss's book "Providence, Ye Lost Towne at Severn". The book lists Henry as "on the adventure" and "Ye commissary".

Henry's life started out more difficult than many, an orphan. The records of St. Mary Woolchurch Haw, London state: "31 Jan. 1622/23. A child left in our Parish and named Henry Woolchurch". Nothing is known of Henry's upbringing, and he appeared in America prior to 1651. It is likely that he came as an indentured servant, but there is no "headright" claim in the record. His first appearance in the land records of Anne Arundel County is in November 1653, when he bought the land of Richard Young along Deep Creek and the Magothy River. He very likely participated in the Battle of the Severn in 1655.

By 1658 Henry had converted to Quakerism, as had many of his neighbors.

In 1662 he was granted the land that would be called "Leonard's Neck", presumably named for Leonard Calvert.

In 1669, the 290 acres that comprised "Leonard's Neck" was assigned to Alexander Gardiner and John Wray from Henry Woolchurch "of Severn River". John Wray's portion was eventually purchased by John Pettibone Gardiner and became Goshen Farm. Alexander Gardiner's portion passed to his stepson, Edward Gibbs, and in turn became the property of St. Margaret's Church.

Henry, his wife Elizabeth, and daughters relocated to Talbot County, along the Choptank River and Tred Avon (Third Haven) river, in present day Easton. In 1682 he was one of 5 men from the Third Haven Friends Meeting who purchased three acres of land on which the Old Quaker Meeting House was constructed. The building still stands, and is reported to be the oldest operating religious structure in Maryland.

The great fire of London in 1665 destroyed the church that was Henry's namesake. The London

Mayor's Mansion House was rebuilt on the site. The Parish was merged with St. Mary Woolnoth.

Upon his death in 1695, he left almost 1200 acres to his heirs. Having no sons and four daughters, Henry's name, like the church that gave him that name, ceased to exist.

There is still a place, close to home, where the name Woolchurch survives. Near the mouth of the Severn, directly opposite the US Naval Academy's Dewey Field, on the east side of the river, is a small indentation of water that bears the name "Woolchurch Cove".

### **Councilman Dick Ladd**

Anne Arundel County Council Fifth District

April 1, 2011

Budget season will soon be here. The County budget is again in a deficit situation ranging between \$30 million and as much as \$70 million. The size depends on the assumptions one makes: more or less furlough days than last year; providing or not providing the full increase requested by the Board of Education; the amount of cash balances there are in various places or how much money the State sends down net of new bills to pay.

The budget office anticipates a small increase in revenue over last year and a need for a virtual freeze on all County expenses. Unfortunately, projected recur-

ring income will not be enough to pay for a number of must-pay increases such as the Board of Education's "Maintenance of Effort," increased debt service costs (interest), insurance and pension costs, along with any additional costs passed down by the State. These additional recurring costs will have to be funded again this year with "one-time sources" of funding from across the County.

The tightness of the fiscal situation and of the municipal bond markets prompted the County Executive to ask the Council to approve a resolution of support for his intent to seek a waiver from the requirement to provide "Maintenance of Effort" (MOE) funding to the Board of Education. I and my colleagues received a very LARGE number of emails expressing strong concern and support for MOE funding. That helped galvanize the new Council's support for continuing our predecessors' approach of working closely and cooperatively with the Board of Education to fund their program to the fullest extent possible within available funds. That process will start in earnest when the County Executive submits his budget in mid-April.

I am very pleased to note the County Executive's appointment of Maureen Carr York and Bill Nevel to the Transportation Functional Master Plan Citizen Advisory Committee. This Committee will look at long term transportation options on the County's major arterial roadways. Of great importance is the addition of Benfield Road to the study.

Planning is underway to extend water and sewer lines across East Jones Lane to provide service to an approved development next to the Arnold Safeway on Ritchie Highway. A portion of that extension will go along the edge of the Arnold Elementary School property and will connect the school to the sewer system. We are hopeful that the construction will also create a dryer, more improved play area behind the school.

Recently we attended the Friends of Kinder Farm Park Volunteer and 4-H Livestock Club recognition and awards dinner. It was another stellar example of "community". If you have not visited the Farm Park side of Kinder Park, you should. The

### Spotlight -Bella's Liquors

Bea and C.G Smith, together with Bea's mother, Bella Novosel, bought a small bar and grocery store in the Cape St. Claire Shopping Center in 1964. They named it the "Bee-Hive Inn," as a tribute to Bea because "things were always buzzing around her." After Bea passed away, the name was changed to "Bella's Seafood and Restaurant" in honor of Mrs. Novosel, who was known to many in the Cape as "Mom Novosel," and was operated by Bella's daughter, Wanda Murray, and her daughter Bonnie Morgan. The liquor store remained with the Smith Family. Bella's Liquors is owned by Charles G. Smith, and is managed by Chris Taylor. Valerie "Val" Sullivan, is

Bella's granddaughter, and is the Office Manager and holds monthly wine tastings. Val's brother, Charles, runs the beer end of the business and Val's son, Eddie, is learning the liquor business from the bottom up. Valerie described how she and her sisters and brother all started working in the kitchen and package goods store as soon as they turned 13 years old. On becoming 21 years of age, they all started working behind the bar. It was truly a family-run business.

Valerie recalled a fond memory

of power outages during snow storms, when her parents and grandmother would open the tavern to everyone and Cape residents would gather around the fireplace, play cards by candlelight and listen to piano music and singing performed by some very talented Cape residents.


Valerie said, "My parents deserve all of the credit for making Bella's what it is today. My mom was a very generous woman who never turned anyone away who needed help. My dad was a sailor, a Pearl Harbor survivor,

who put himself through college. My dad was the money manager and my mom was the personality. And in this business you really do need a lot of personality!"
