Board In Brief *CSCIA Board Of Governors Monthly Meeting*

APRIL 8, 2024

In attendance in person: Pres. Jerome Zadera, Govs. Joe Angel, Beau Breeden, Cheri Fairchild, Thor Harris, Ed Hayes, Mary Lamb, Matt Layman, Neil Macindoe, Michele Shipley, Town Manager Frank Tewey, Budget Committee members Charlie Moore, Blake Morris and Charlie Shoul and guests Cathy Gazzo, Larry Jennings and Stacy Wildberger.

Pres. Zadera called the meeting to order at 7:31 pm, thanked all for coming and noted that parking stickers must be displayed on cars parked at Cape properties by May 1. He announced a last-minute variance request and a motion to add the hearing to the agenda under New Business was made and approved unanimously.

MINUTES AND FINANCIAL STATEMENTS

Minutes of the Mar 11, 2024 BOG meeting were reviewed, a motion made to accept and approved unanimously.

The financial statements for Feb 2024 were discussed, a motion made to accept and approved unanimously. Balances of the bank accounts were: Operating funds- \$228,000, Beach restoration grants- \$197,000, piers- \$237,000 and Special Community Benefits District (SCBD)- \$219,000.

TOWN MANAGER REPORT

Town Manager Tewey said about 87% of expected FY24 revenues for maintenance fees have been collected.

Security officers are covering 23 of 30 evenings in April. A fourth officer was hired.

The first portable restrooms were delivered. More to come in mid-May. A memorial bench was installed, and a dedication held by the donating family. They were very pleased with the bench and the service they received from all involved. A motion to accept the invoice presented by Town Manager Tewey to be sent to the family for final costs was made and approved unanimously.

Interviews were held for beach attendant positions. A schedule is done for coverage through the summer, including special events.

Slip contracts were due March 15. Matt Cox has done a great job, has completed moves and is working the waitlist offering mud slips.

A variance request was approved at the county administrative hearing to allow a deck with less than required setbacks. CSCIA approved after the county hearing. Five standard applications were processed, four approved and one to be discussed. An easement agreement was executed and approved.

The 2nd reading of County Bill 16-24 concerning outdoor dining will occur at the next county council meeting. A request was made for a bill to allow for money collected from SCBD payments to be saved for the Reserve but there is an issue with the county law office. State House Bill #752 regarding ownership of land in tidal wetlands was in committee as of April 5 and the legislative session ends tonight.

Paperwork for the Mosquito Spraying Program was submitted. Notices will be put in the Capers, the CSCIA website and Facebook page if granted. For those to wish to opt out, information will be available on how to do so.

The Articles of Incorporation amendments were taken to the attorney.

On April 13, Gov. Angel will represent CSCIA at the beach cleanup to be done by Broadneck High School students.

COMMITTEE REPORTS

Broadneck Council of Communities (BCC): Gov. Breeden announced the general meeting was postponed to April 25 at 7pm at the clubhouse. County Councilwoman Amanda Fiedler, Senator Gile and Delegate Bagnall are expected to attend and the Office of Planning and Zoning is invited to present regarding rezoning issues in our region. The transition of the Holly Beach Farm from the Chesapeake Bay Foundation to the Department of Natural Resources may be discussed. The BCC would like it to become a sanctuary and educational center like Jug Bay, open for educational groups but not the general public.

Business Lot Owners Association (BLOA): Gov. Breeden reminded all that bikes on sidewalks and loitering are not allowed. He asked that anyone who sees graffiti report it as soon as possible.

Capers: Gov. Lamb said the online editions are posted on the 1st of the month, delivery to mailboxes is later.

Clubhouse: Gov. Lamb reported rentals are still steady and the new cleaning company is still doing an exceptional job.

Our community is coming alive with the warm weather! As we take to outdoor activities, please remember to help us maintain our fabulous community amenities. Let's commit to leaving things better than we found them. When enjoying the beach, using the marinas, playing in our parks or hiking our community trails, please take the time to remove any litter.

Silver is the new Orange! Parking stickers and guest passes have been mailed out! Your new SILVER stickers should be affixed securely to your vehicle. Guest passes must be hung from the rearview mirror entitles your guest to parking privileges only. When using our beaches, parks, and marinas guests must be accompanied by a Cape resident.

Help your Cape ambassadors! Our Beach Attendants will begin duties in May. They are tasked with providing Cape residents with an enjoyable day at our beaches and marinas. They will monitor parking areas to ensure Cape residents and permitted guests have exclusive use of community lots and they will verify eligibility of those entering our Community parks and beaches. Your cooperation is truly appreciated! If you have any questions, just ask! You may email me at townmanager@cscia.org with any questions, concerns, complaints and compliments!

Taking on a summer construction project? Be sure to always refer to the CSCIA Building Code at CSCIA.org before planning or starting a project. As required, all build requests should be forwarded to the Building Committee for covenant compliance review. Submittal directions and forms are readily available on the website. Please submit any requests at least 30 days ahead of any scheduled work!

Did you know? Use of any temporary storage container on your property is limited to 60 days. All vehicles, trailers and boats on your property must be properly tagged and/or currently registered. Commercial vehicles of 10,000 pounds or more can not be parked in a residential area. If you have any questions, please call the CSCIA Office, we're here for you!

Board In Brief *CONTINUED*

Events: Gov. Lamb said the Easter Egg Hunt/Online Egg Hunt were very popular. Pres. Zadera commended Gov. Lamb on the egg hunts.

Piers: Gov. Breeden reported 95% of pier revenue has been received. He commended Matt Cox on his work on pier assignments. About 45 people on the waitlist have been contacted about mud slips and subleases available because of those who may not have boats in by the deadline due to maintenance or retrieval from storage issues. Water will be turned on Apr 15 and any necessary repairs made. Portable restrooms are in at Lake Claire and Deep Creek. The first pier meeting was April 2 and 16 people attended. Requests for Proposals were sent out for full replacement of the small pier at Deep Creek (DC) and the area around the boat ramp, with work planned for winter of 2024-25. Bids are coming in much higher than those received a few years ago. The DC small pier T makes the total pier length 175 ft, which requires a standpipe per county rules, is not included in the bids and could cost another \$30K. Tidal wetland permits are required. Slip fees may have to increase earlier than was hoped to replenish the reserve.

Security: Gov. Breeden asked that everyone review beaches and parks rules such as who is permitted to use the beaches and when. Parks close at 10 pm, no fires are allowed except in the grills, and no one should trespass through private properties to access the parks.

Strawberry Festival: Gov. Lamb said there is a lot of interest and planning is going well. Organizations are encouraged to have free events for kids. She cannot get the physical permit until a liquor license is approved. The parade permit application for July 4 was submitted.

OLD BUSINESS

Pres. Zadera reported the board will help partially fund the Girl Scout Gold Award little education library project if needed. National Fish & Wildlife Foundation (NFWF) awarded CSCIA a \$75,000 grant plus matching funds for volunteer hours performed of \$321,000 for advance, design and permitting for living shoreline, stream restoration and best stormwater practices at 5 sites. Gov. Breeden said applications are being made for construction grants. He answered a question about receiving funds, saying that NFWF provided instructions for that process. Bylaw changes voted on in Jan. were recorded at the county.

Town Manager Tewey announced that the Certificate of Insurance was received for Cinco de Mayo outdoor dining at Broadneck Grill.

NEW BUSINESS

Pres. Zadera reported that there are potentially dangerous trees between the Walnut Ridge community and Cedar Tree Lane in the Cape. The trees are not on Cape property. Walnut Ridge has been made aware of the issue but has given no response yet.

A Girl Scout troop has applied to become a Cape Recognized Organization and that will be discussed in closed session.

VARIANCE REQUEST

A variance was requested for the height of a seawall. CSCIA does not own the riparian rights there. It will be discussed in closed session.

COMMENTS

Budget Committee Chair Charlie Moore presented possible dates for the budget organizational meeting. It was set for May 9 at 7:00 pm.

Blake Morris asked about plans for the Bella's trailer for serving alcohol. Gov. Breeden said that the permitting process and liquor licensing is going to take a lot of time. The owner may be able to be hired by events that hold a liquor license.

Stacy Wildberger from Cape Conservation Corps (CCC) said the Master Gardener program/pollinator garden and Project Clean Stream events went well. She thanked the volunteers and Matthew's Hauling. Wednesday Weed Warriors are starting their full schedule now. A kickoff event will be at Little Magothy beach. CCC will have a table at the Goshen Farm Open House. Planting at Little Magothy Beach will be May 4. The Girl Scout libraries are to be installed in July. CCC is looking to do another plein air event. The fundraiser night at Broadneck Grill is Apr 17. Mrs. Wildberger was approached by the Watershed Steward program regarding revamping the rain garden and it was decided to postpone that pending plans for a deck.

ADJOURNMENT

A motion was made to adjourn to closed session and approved unanimously. The meeting was adjourned to closed session at 8:26 pm. The closed session occurred from 8:33 pm to 9:47 pm. The April 8, 2024 CSCIA Board of Govs. meeting was adjourned at 9:47 pm.

Summer Safety:

Beyond Sunscreen!! But yes! Let's talk about sunscreen!!



~Home swimming pools must have fences and locking gates (most drownings of children age 1-4 happen in home swimming pools).

Hi Capers!

It's finally summer (just about)! Thank you to everyone who suggested topics. Summer tips was one of the most suggested so here we go! Most of these are reminders, but if you're just hearing them, that's great too! Let's stay safe together!

Sunscreen!

Yes! You must wear it! Every day. No matter what! Yes! Even if it is cloudy! In the summer, spf of 30 or greater is recommended. But wait! What is spf? Great question! SPF is an abbreviation for "sun protection factor" and basically means how much time you have before you burn. For example, "SPF 15" means you have 15 times longer in the sun before you burn. So, for simplicity, without sunscreen, if your skin burns in 1 minute and you applied spf 15 sunscreen, you'd have 15 minutes before your skin burned. That is, if you applied it correctly! Correct sunscreen application = apply to dry skin 15-30 minutes before going outside. Allow lotion to absorb into skin.

And here's the thing: spf is not additive. Meaning you cannot apply a lotion of spf 50 and a spray of spf 15 or 30 on top to make an spf >50; and stay out longer in the sun! The higher spf is the maximum, as long as it is applied properly. So in this example, the spf of 50 is the max. Special Note (and a common misconception): the spf number does not indicate how many hours you can stay in the sun without burning. For example, Spf 15 does *not* indicate you can stay outside for 15 hours!

So here are the basics (from the American Cancer Society): spf 30 or greater that is "broad spectrum" (blocks UVA and UVB rays) is ideal. Reapply after swimming and/or sweating. Reapply often (at least every 2 hours). Start your day in the sun with a thick lotion and apply it at home before you hit the beach or pool. Touch up with more lotion or a spray sunscreen every 1-2 hours! When in doubt, reapply!!! Additionally, seek out the shade and wear a hat and sunglasses to protect your eyes, and lip balm with spf!

Water Safety!

First things first, according to the CDC "drowning in the leading cause of death for children".

Non-negotiable water safety includes:

- ~wear well-fitted life jackets when boating and swimming.
- ~close supervision of pools and natural waters is essential. **Drowning is a silent event!** Movies portray drowning as noisy with thrashing and yelling. This is usually not the case. Therefore, CLOSE SUPERVISION OF ALL CHILDREN IN POOLS AND NATURAL WATERS IS ESSENTIAL AND NON-NEGOTIABLE.

Bay Safety!

Our Chesapeake Bay and the rivers that feed into it are one of the main reasons we love our neighborhood. We are so fortunate to have water access year round, and especially during the summer. But our Bay is compromised and it can affect human health. Here are the basics:

1. Do not swim in the Bay/rivers if you have open cuts or wounds, an ear infection or perforated ear drum. Harmful bacteria can enter and cause major problems ranging from diarrhea to flesh eating infections.
2. Allow 48 hours before swimming in the Bay/rivers after a rain storm. This timeline allows for two tidal cycles after the rain washes bacteria and nutrient-rich runoff into the water. (Personal note: this rule is so difficult. When my kids were little, we had to decline parties at the main beach because it rained the day before. It is devastating especially if other families don't follow this rule, but incredibly necessary!)
3. Wear water shoes when swimming from beaches. We cannot see the bottom most times when we are swimming at Lake Claire or the Main beach. Natural debris such as oyster shells, rocks and sticks can cut skin and open us up to infection. Sadly, there is always the risk of unnatural debris such as glass, needles, or metal on the bottom of the Bay that open the skin and may be contaminated with especially nasty bacteria and viruses.
4. Do not swim on any day without checking the Anne Arundel County Health Department water report. Our health department monitors bacteria levels and updates citizens frequently. Visit <https://www.aahealth.org/environmental-health/recreational-water-quality/water-quality-report>
