Hope everyone had a fun and safe Memorial Day weekend. As I am writing this, we are having our first week of "summer weather" and hopefully the cooler, wet spring weather has passed and we can all adjust quickly to the hotter temperatures. The Strawberry Festival is being held June 4th, it looks like Mary Lamb's and the Strawberry Festival Committee's arduous work over the last year is paying off and hopefully we will have a back to normal day full of fun for the family as we mark the start of summer, rather than last year's festival, which was at the end of summer.

We, as an association, have been busy with the business of Cape St Claire. When you have 2,300+ homes and some 8,000 residents, the work never seems to stop, but as spring comes to an end and we move into summer, it gets busier and busier. I'd like to thank Lisa Schmidt for her last 4.5 years of volunteer efforts on the Board of Governors. Any volunteer time is appreciated, and the excellent work Lisa did with the 4th of July Parades and games the last few years goes above and beyond. As life returns to "normalcy," all volunteers are taking stock of their work/life balance and having to make difficult choices that we didn't think about before the pandemic period. If you see Lisa out, be sure to thank her for her time and efforts to the community!

- You should see the beach attendants on the weekends at our beaches. Unfortunately, due to school ending so late, this will be mostly limited to weekends (Fri-Sun) until most of them are out of school. Please be respectful of the beach attendants, as they are there to help make sure

our residents and their guests have a fun and safe time at the beaches and parks.

- If you are a slip holder at one of our three community marinas, please remember your boat should be in the water by June 1st per our contracts. If you will not make that date, you should have been in contact by now with the Piers Committee and Administrator to make other arrangements, like subleasing for a period of time, so we can efficiently use the slips amongst those on the sublease list and wait list where possible.
- As we continue to monitor our Beach Projects, we have about ten transects between the two beaches that are being monitored and measured for sand movement both onshore and offshore as winds and waves move the beach. The more documentation we have over time, the better the engineers and planners can help us in the future phases of restoration at our Main and Lake Claire beaches. We also will be engaging in further conversation with Cape Conservation Corps and other community members about projects at our other five sites, and how we may be able to begin to work on future improvements and restoration in the near future.

I wanted to let you know on Thursday, May 12th, we had the opportunity to host Peter Franchot, the Comptroller of Maryland, at our Main Beach. Mr. Franchot and his staff wanted an official visit of one of the projects Mr. Franchot had voted on in the last

few years on the Board of Public Works. As one of three voting members, the Comptroller supported the CSC Shoreline Restoration project by voting for our MDE Tidal Wetlands Permits and Modifications, along with final funding on two separate Bond Bills in 2019 & 2021. At the visit, members of the Board of Governors and our Town Manager were joined by members of our CSC Shoreline Restoration Team, including Biohabitats, Shoreline Design, Alliance for the Chesapeake Bay, and the Little Magothy River Association. I want to thank Mr. Franchot for coming to see the project, meeting and discussing with us the time and effort it took during the last decade to accomplish a project that includes funding from community, non-profits, the county, state, and federal government. Lastly, I am going to be a broken record this year and continue to ask for help. Please consider working some shifts at the Strawberry Festival, helping out at a Weed Warrior Wednesday, or volunteering with the CSC Volunteer Fire Company. Join Goshen Farm and the Garden Club, pick up trash around the community on your own time, come to our membership meetings to learn more about our community, and consider joining the Budget Committee or the Board of Governors in 2023.

By this time, you should have received your Cape parking stickers and they should be placed on your vehicles. Remember they must be affixed to your vehicle and not placed in the dashboard. Guest passes are not valid for trailering at Deep Creek on Friday, Saturday, and Sundays. Towing procedures are in place, please be mindful of the many parking restrictions around the community. Beach Attendants have been trained to be kind to our residents and we ask that you do the same for them in return.

Fireworks are one of the most anticipated and thrilling traditions to celebrate our great nation's birthday. Any firework that explodes or launches a projectile in the air or moves on the ground is illegal in Maryland, including firecrackers, cherry bombs, black cats and M-80s.

Board In Brief *CSCIA Board Of Governors Monthly Meeting*

MAY 9, 2022

In attendance: Pres. Beau Breeden, Governors Jeff Roche, Neil Macindoe, Cheri Fairchild, Michele Shipley, Joe Angel and Mary Lamb, Town Manager Ryan Anderson, Budget chair Charlie Moore, and guests Steve Arnold and Stacy Wildberger.

Pres. Breeden called the meeting to order at 7:31 pm. He noted that weather has kept the beaches quiet but preparations for the summer continue. Sand was removed from the parking lot at Lake Claire and pushed back onto the beach. The piers are ready to go for the June 1 deadline to have boats in. As of May 1, new stickers should be on cars parked at CSCIA property.

MINUTES AND FINANCIAL STATEMENTS

Minutes of the April 1, 2022 BOG meeting were reviewed and approved unanimously.

The financial statements for March 2022 were reviewed. Pres. Breeden pointed out unusual expenses such as loss of some large trees and ongoing legal issues, improvement in clubhouse revenues, and that the final SCBD check is due from the county. The financials were approved unanimously.

COMMITTEE REPORTS

Beaches and Parks: Gov. Macindoe said beach activity is increasing. New grasses and sand accretion continue to be monitored. Pres Breeden added that monitoring is done by GPS, lessening the impact of the actual stakes being moved or lost. The contract with Alliance for the Chesapeake was extended to continue monitoring and to complete recording of reports.

Business Lot Owners Association: See Town Manager's report.

Broadneck Council of Communities: Pres Breeden reported the BCC will host a forum with the county executive and the highway administration on May 19 at the clubhouse for discussion about the Bay Bridge, the potential national park at Holly Beach, and more.

Budget: Charlie Moore announced that monthly meetings were scheduled through October. The meeting on May 19 will begin the line-item review and update assumptions for a new budget based on the expectations of higher-than-normal inflationary pressures.

Building: Gov. Roche reported two revised applications were received with changes made per county requests and will be discussed during closed session. He will be turning over all committee chair responsibilities to Gov. Shipley as he is moving from the Cape.

Caper: Gov. Lamb said delivery of the Caper is still an issue, but there has been improvement.

Clubhouse: Gov. Lamb reported that rentals are booming.

Covenants: No report.

Events: Gov. Lamb announced the Cape Clean Up is scheduled for Sept 23 and 24.

Legislative: No report.

Piers: Pres Breeden said poor weather has prevented most slip holders from putting in their boats, but he expects them in by Jun 1. If a slip holder cannot have a boat in by that date, they need to contact the pier committee. Slip holders cannot sublet their slips. It must be done through the committee.

Security: See Town Manager report.

Strawberry Festival: Gov. Lamb said they are in the final phases of planning. There will be a vendor meeting on May 23. The Broadneck High School band will perform in the parade, and several politicians will participate.

Technology: Pres Breeden said he has worked with Bill Szczytko to research a paid Google Workspace account.

Town Manager: Town Manager Anderson reported the "chronolog" sign was installed at Lake Claire with a case for placing a cell phone to take a photo of the beach. Anyone who uses the case can upload photos to a website to show changes. New plants were added near the inlet and goose netting was removed. There is an option to add a fence around the plants if needed. Mr. Anderson has hired beach attendants. Additional portable restrooms will be installed May 13, and the rental price has increased. Weekly water monitoring by the county health department will begin on Memorial Day weekend. State Dept. of Agriculture mosquito spraying could begin as early as May 25. The memorial benches removed have been reinstalled. An issue with unauthorized business being conducted on the beaches is being addressed. Slip holders need to contact the pier committee if they cannot get their boat into their slip by Jun 1. There are 92 people on the pier slip waitlist. The Lake Claire gate lock is to be replaced. No permit has been issued for the Deep Creek dredge and we still have not received an answer to the application of the beach project as a fee in lieu of. Two security officers are covering 10 of 31 dates in May and Gov. Macindoe is covering the remainder. Restripping of handicapped parking spaces at the shopping center has not yet occurred.

OLD BUSINESS

Pres Breeden reiterated the need for cloud storage space as the current free program is expiring. A motion that CSCIA use funds from the technology line and the office supplies line of the budget to pay \$720 to upgrade to a year of Google Workspace and passed unanimously.

NEW BUSINESS No new business was discussed.

COMMENTS

Stacy Wildberger reported that the Cape Conservation Corps (CCC) had about 25 volunteers create a shade garden at the Little Magothy beach. Permission was asked to install a bench at the rain garden, and details are to follow regarding placement and installation method. The native plant swap went well. Weed Warriors will continue to monitor for Bush-killer vine and determine if spraying is needed. The Habitat Heroes tour of the 2021 winning yards will be Jun 18. Pres Breeden commended her the great work CCC has done.

A resident asked about the history of CSCIA ownership of properties and riparian rights. Pres Breeden gave a brief overview. Gov. Shipley referred him to the Maryland Land Records for details. Discussion followed regarding monitoring of transects and the effectiveness of the cobble bar, what is allowable under the current permits, and the status of applications.

ADJOURNMENT

A motion was made to adjourn to a closed session and approved unanimously. The May 9, 2022 CSCIA Board of Governors meeting was adjourned to closed session at 8:10 pm.

CLOSED SESSION

A closed session was convened at 8:10 pm and adjourned at 8:53 pm. The regular session of the May 9, 2022 meeting was adjourned at 8:53 pm.

The Value of Cape Trees

When we moved to Cape St. Claire over 30 years ago from the mountains of California, we were looking for a community that felt like a healthy place to live and raise our kids. We were attracted to the Cape the first time our realtor brought us here. We liked the diversity of houses, walkable streets, schools and shopping center, the access to the water and beaches, and the sense of both old and new that speaks to a stable community. But the other thing that really sold us were the TREES!

I admit I love trees. They are truly one of the most amazing creations on earth. Whether the massive strength of an oak, a unique bald cypress, a dogwood in bloom, a sugar maple in the fall, the showy magnolia, or the grand statement of bark and leaf that is the sycamore.

On some level, I think most people appreciate trees and forests. They appreciate their beauty, or as a place for wild things to live, or for shade on a summer afternoon. But most people underestimate the value of trees in the environment and in their daily lives. Trees and forests are much more than just scenery, landscaping, or a nice place for a picnic or walk. Trees and forests work for us every day,

I once read (and often repeat) this hypothetical question. *"What if we asked our best engineers to build a machine that could filter pollution from air and water, suck CO₂ out of the atmosphere and store it for 100 years or more, cool our homes and cities, and reduce our energy consumption AND this machine would need to do all these things without using any fuel, have a minimal cost to maintain, and could be delivered in so many colors and sizes, that everyone would want one installed in their neighborhood?"* Well, you get where this is going....it would look like a tree!

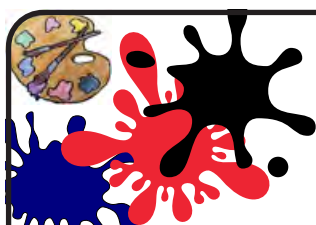
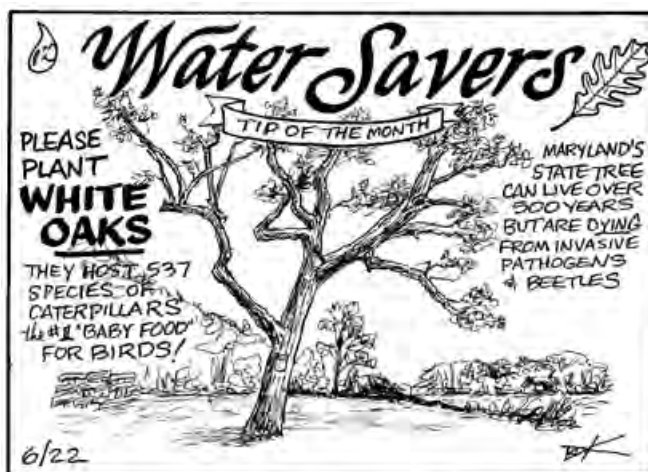
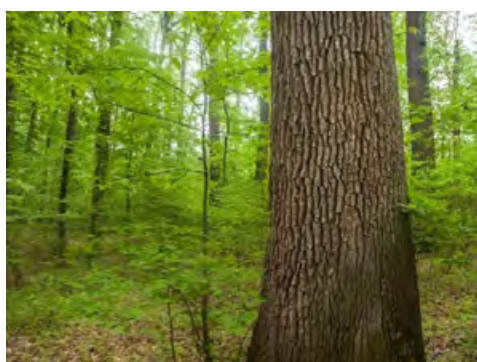
But let's not miss the forest for the trees. The health of the Chesapeake Bay is tied in part, to its trees and forests. Pollution increases when the amount of trees and forests decreases in a watershed. With the trees canopy of leaves

and branches, its understory of small trees and shrubs, and a ground surface of deep organic litter, it is easy to understand why forests are nature's best tool for taking care of the land.

Trees break the impact of intense rain and serve as an umbrella protecting the soil below. They essentially serve as a giant sponge – absorbing rainfall and allowing it to infiltrate slowly, recharge groundwater and slowly feed our streams throughout the year. I challenge you to go out in the woods during a heavy rain...you will rarely if ever see any water running off.

Right now about 60% of the Chesapeake Bay watershed is covered by trees but believe it or not, we are losing forests to development at a rate of nearly 100 acres each day.

So when you are driving down Cape St. Claire Road or along Hampton Road, take a moment to marvel at the giant oaks, poplars and maples that grace our community. Thank those trees for all they do including saving us all money on our summer electric bills and adding to our property values. And the next time you complain about raking leaves in the Fall, take a moment to consider all the work those trees are doing for you every day....for free!

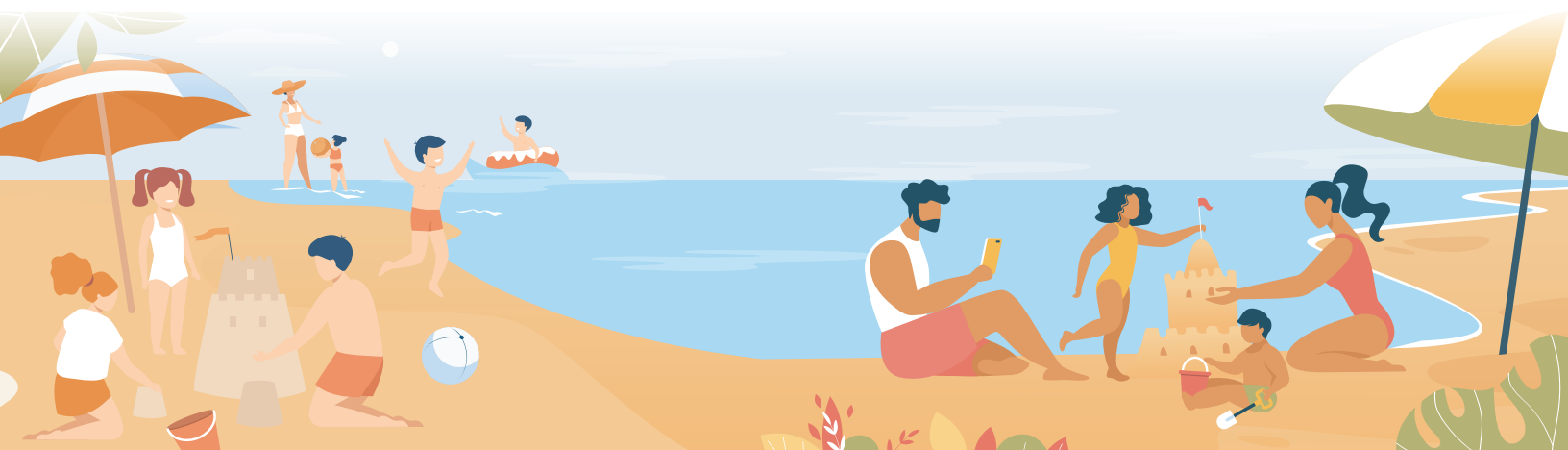

Beaches and Parks Rules and Regulations

1. **Beaches, parks and the boat ramp at Deep Creek are only for the use of property owners current in the payment of their maintenance fees, and their accompanied guests.** Guest passes cannot be used for the launching ramp at Deep Creek Fridays through Sundays. Guest passes may be used for vehicles without trailers at Deep Creek during all regular park hours.
2. **All Cape St. Claire beaches and parks will be closed to everyone from 10 p.m. to 6 a.m. Violators will be subject to prosecution under the Maryland Trespass Law, Annotated Code of Maryland, Article 6-402/6-403. Conviction under this law may involve a fine of not more than \$500 or a 3 month imprisonment, or both.**
3. **Vehicles parked on community property must display their current assigned Cape St. Claire bumper sticker on the rear of their vehicle, or a guest pass hanging from the rear view mirror, or a temporary parking permit (issued for special events held at the clubhouse) inside the front windshield on the drivers side.** Any unauthorized vehicles will be towed at the owner's expense.
4. No loitering is allowed in the community parking areas.
5. No motorized vehicles are allowed on the beaches and no boats are allowed on the beaches or anchored at the beach waterline. This includes golf carts, motorized scooters or other On Road Vehicles (ORV.) ORVs may be parked on community owned parking lots with valid parking passes.
6. Windsurfing is permitted outside of the designated swim area only.
7. **Consumption of alcoholic beverages IS NOT permitted on the beaches, in the parks, or in the community parking lots. Glass containers are not permitted at our beaches.**
8. **Dogs on community property shall be on a leash and within their owner's control at all times.** Dog owners must clean up their dog's waste. Bags are provided at the beaches for your convenience.
9. No commercial use of the piers, beaches or parks is allowed
10. The use of piers is limited to slip renters. **Fishing and crabbing from the community piers continues to be prohibited**, except from the fishing and crabbing pier at Lake Claire. Residents are also reminded that the boat piers are totally maintained and paid for by slip renters.
11. Dumpsters on community property are for the use of people using these facilities, not for household refuse.
12. **Permission for social gatherings of 20 or more people at the beaches and parks must be requested in writing from the CSCIA Beaches and Parks Committee, and the appropriate permission form must be completed and signed by the sponsor(s). Social gatherings of more than 30 people will need special permission from the Beaches and Parks committee chair.**
13. Violators of these policies may be banned from CSCIA properties and trespassers will be prosecuted.
