Board In Brief CSCIA Board Of Governors Monthly Meeting

MAY 13, 2024

In attendance in person: President Jerome Zadera, Governors Beau Breeden, Cheri Fairchild, Ed Hayes, Mary Lamb, Matt Layman, Town Manager Frank Tewey, Budget Committee members Blake Morris and Charlie Shoul and guests Becky Benner and Stacy Wildberger. In attendance online: Governor Michele Shipley.

President Zadera called the meeting to order at 7:35 pm, noted that parking stickers must be displayed and asked everyone to use caution when driving and be aware of kids on bikes and skateboards. Please review the beach and park rules. Remember to lock your car doors even in your driveway. He announced that Governor Connor has resigned from the board and filling the vacancy will be discussed if necessary. The clubhouse will be used as a polling place on May 14 and please exercise your right to vote.

MINUTES AND FINANCIAL STATEMENTS

Minutes of the April 8, 2024 BOG meeting were reviewed. A motion was made to accept the minutes and approved unanimously.

The financial statements for March 2024 were reviewed. A motion to accept the statements was made. Balances of the bank accounts were: Operating funds-\$203,000, Beach restoration grants-\$195,000, piers-\$327,000 and Special Community Benefits District (SCBD)-\$380,000. The motion passed unanimously.

TOWN MANAGER REPORT

Town Manager Tewey said there were very few updates since his report at the quarterly meeting in April. Off duty police officers are covering 25 of 31 days in May, the budget meeting will be Thursday May 16, and 4 building applications were approved.

COMMITTEE REPORTS

Broadneck Council of Communities (BCC): Governor Breeden announced Amanda Fiedler, Senator Gile and Delegate Bagnall attended the general meeting. Rezoning issues were discussed. The pilot program for traffic control will be implemented this weekend, with Exit 32 at Oceanic Drive closed Friday- Saturday afternoon. Traffic lights are being installed at Exit 29 and 30, and on St Margarets Road at Pleasant Plains. Options are being tested to see what works for all involved. A BCC representative will attend the Anne Arundel Co. Homeowners Association summit with Growth In Action to be held on June 1. Reserve studies will be discussed.

Beaches & Parks: Governor Breeden reported that beach attendant training was held on May 11, with 19 in attendance to learn about Cape rules, confrontation de-escalation, etc. Town Manager Tewey will create a schedule for the entire summer soon

Budget: Governor Shipley reiterated the May 16 date for the budget meeting.

Caper: Governor Lamb said the latest issue was out early. Reduced activity in home sales has caused realtors to cut back advertising. The coupon issue will increase ads. Groups providing articles are limited to one page unless they are willing to pay for more pages.

Clubhouse: Governor Lamb reported rentals are still steady and the new cleaning company is still doing an exceptional job.

Events: Governor Lamb announced the Cape Clean Up will be Wednesday morning through Friday morning, June 12-14.

Grants: Governor Breeden reported that the National Fish & Wildlife Foundation will be visiting on June 3 from 9-12 regarding the \$75,000 design and planning grant awarded and the pending grant application. All governors are invited to join the tour.

Piers: Governor Breeden commended Matt Cox on pier assignments and suggestions for improvements to the system. Boats must be in slips by June 1. If your boat cannot be in by that date, contact the piers committee as soon as possible.

Strawberry Festival: Governor Lamb planning is in full swing and that the banner went up over Cape St Claire Rd. There are still a couple of spaces available for corporate sponsors to provide free events for kids at the park.

OLD BUSINESS

President Zadera reported no response from the Walnut Ridge community regarding potentially dangerous trees between them and Cedar Tree Lane in the Cape. There has also been no update from the county regarding the proposed crosswalk.

Board In Brief CONTINUED

NEW BUSINESS

Town Manager Tewey said residents Dave Jones, former meteorologist, and Eileen Prager, marine scientist, have identified a \$3000 grant for equipment and installation of a water level sensor. Community partnerships are being sought to report water levels to the National Oceanic and Atmospheric Association (NOAA), the National Aeronautics and Space Administration (NASA) and the United States Geological Survey (USGS). Our website could link to the Geocollaborate website and supply real-time tide information and predictions. Mr. Jones and Ms. Prager will write the grant. Discussion followed regarding placement and requirements of the grant. Governor Breeden will follow up. A motion to allow Mr. Jones/Ms. Prager to submit the application on behalf of CSCIA passed unanimously.

Governor Lamb thanked the Hargrave twins for rebuilding the Strawberry Festival ticket booths for their Eagle Scout project.

Governor Lamb spoke regarding the volunteer who provides information tech support. She feels that given the amount of time it involves maintaining IT needs, he should be compensated. Discussion followed regarding budgets, salary vs. payments, etc. She will report back after speaking with the volunteer.

President Zadera reported Al McCullough of Sustainable Science was at the main beach to monitor transects.

Anne Arundel Co. has introduced legislation for the Department of Inspections and Permit to adopt the 2021 International Building code and 2020 National Electrical Code per Maryland law for commercial buildings.

The Harbour School education visit will be June 11.

Governor Breeden presented proposed rezoning for Region 4. He served on the Stakeholders Advisory Committee for the past two years. Bill 27-24 is for the General Development Plan. For CSCIA owned properties, most of the recommended changes are to Open Space (OS) or Marina (MA1). Boat storage can only occur on lots with the MA1 designation. After discussion, a motion was made to accept the final recommended zoning changes and passed unanimously. Bill 28-24 is for Comprehensive Zoning consistency. Most of the recommended changes are for lots with more than one zoning designation. The goal is to simplify the designations to one per lot, consistent with its use. For example, some lots are designated as Residential, 5 house per acre (R5) and Open Space (OS) because of a steep slope or land in the critical area. If that lot has a home, the recommendation is for all R5, as the steep slope or critical area cannot be developed anyway. If the lot is not buildable and has no house, it may be recommended to be all OS. At the Deep Creek marina, CSCIA owns the land along the water behind the homes, zoned R5 and MA1, with all MA1 as the suggestion. Discussion followed regarding current and potential use of various lots and the pros and cons of the designations. Suggestions for changes other than those proposed must be made to Councilwoman Feidler who can introduce an amendment. Requests for changes can be made again in the next rezoning in 10 years. A motion was made that Governor Breeden be given authority to act on behalf of CSCIA to review the proposed changes and make recommendations to the county based on his knowledge and experience with the subject. The motion passed with one abstention.

COMMENTS

Charlie Shoul reminded everyone of the budget meeting.

Becky Benner reported the Garden Club plant sale will occur rain or shine on May 18 from 8 am-2 pm. The next monthly meeting will be June 4 to discuss the sale successes and areas for improvement. On June 8 they will go to Chanticleer and Stoneleigh gardens. There will be no Garden Club events in July or August.

Mrs. Benner also reported that the Goshen Farm Preservation Society will have a booth at the Strawberry Festival. Their next event for the public will be Wine Down at the Farm on August 18.

Stacy Wildberger of Cape Conservation Corps (CCC) said 27 volunteers put in 61 hours planting at Little Magothy Beach on May 4. Wednesday Weed Warriors is ongoing. 84 Lumber will supply at no cost all construction materials needed for Rebecca Sawyer's Little Learning Libraries to be installed at the Serene Ravine and Little Magothy Beach. The Habitat Heroes tour will be held on June 4 at 5:30 pm. CCC will have a booth at the Strawberry Festival where kids can plant milkweed seedlings in newspaper pots to take home.

ADJOURNMENT

A motion was made to adjourn to closed session and approved unanimously. The meeting was adjourned to closed session at 9:02 pm. The closed session occurred from 9:04 pm to 9:34 pm. The May 11, 2024 CSCIA Board of Governors meeting was adjourned at 9:34 pm.

Christmas in July! Seeing Red this Summer: Donate Blood!

Hi Capers!

There is no substitute for human blood when patients need a transfusion. Therefore, it is paramount that hospitals store blood from donors so blood is available when needed. The FDA is responsible for regulatory oversight of the U.S. blood supply. The Red Cross provides around 40% of the nation's blood and blood components. Our hospital, Luminis Health Anne Arundel Medical Center (LHAAMC) maintains its own blood bank relying on volunteer donors to fill the need for the hospital. "We [Luminis Health AAMC] use blood for all patients, including:


- Accident victims.
- Surgery patients
- Babies.
- Children and adults with acute burns or blood clot problems.
- Those with catastrophic diseases, such as leukemia and hemophilia.

Blood donation is essential for community health. According to the American Red Cross, "every two seconds, someone in the U.S. needs blood". Therefore it is essential to maintain a bank of blood, at the ready, when needed.

THE BASICS OF BLOOD

Blood is categorized into four "blood types" based on the presence or absence of certain antigens. Antigens are "substances that can trigger an immune response if they are foreign to the body" (redcrossblood.org). Safe blood transfusions depend on careful blood typing and matching, which is completed for each donor and recipient. Below is a table of compatible blood types and recipients:






Additionally, the presence of a protein known as "Rh factor" is either present (+) or absent (-) resulting in the 8 blood types.

O- is the universal donor blood type because it can be used in transfusions for people with any blood type. AB+ is the universal recipient blood type, meaning that people with this blood type can receive blood from any other type. O+ is the most common blood type in the United States. 37.4% of the population are O+! People are born with a blood type and it can only change in rare circumstances such as with certain types of leukemia, cancers, autoimmune diseases, or rare infections or with a bone marrow transplant.

While it is important for all eligible humans to donate blood, it is especially important for the O blood types because they are most often used in emergencies. With O- as the universal donor, and O+ the highest percentage of the population, it is especially important to give if you have these types Additionally, our NICU and premie babies can only receive O+ or O- blood.



BLOOD DONATION BASICS

The following guidelines are from our hospital (LHAAMC) as this is the closest donation spot to Cape! The LHAAMC Blood Donation Center is located on the 4th floor of the Wayson Pavilion. Parking is in Garage B "for blood"!!

BASIC REQUIREMENTS FOR BLOOD DONATION

- You are between the ages of 17 and 74; 16 with a signed parental consent form.
- You are in good health.
- You weigh at least 110 pounds if you are 21+ years old. If you are between the ages of 16-20, you must meet relative height and weight requirements.

DONATION FREQUENCY

- You may donate platelets as often as every 28 days.
- You may donate blood as often as every 56 days.

There are also restrictions in eligibility for blood donors and an extensive screening process is completed each visit. Per LHAAMC guidelines, you cannot donate if you have conditions including:

- AIDS, or are at risk for AIDS.
- Blood disorders or bleeding tendencies.
- Brain or spinal surgery that required a transplant of brain covering (dura mater).
- Cancer. (People with basal cell or squamous cell skin cancers or keratosis can donate if the lesions have been removed and skin has healed.)
- Colds, fever, flu, sore throat, cough, respiratory infection or headache.
- Hepatitis or undiagnosed jaundice after age 10.
- Melanoma (must wait five years and obtain pathology approval).
- Positive hepatitis test.
- Intravenous drug user, or history of intravenous drug use

Additionally, recent tattoos or piercings make one ineligible for a short time after.

LHAAMC states:

"All donor requirements are in place to ensure the safety of those who receive our life-giving blood supply".

Donor blood is rigorously tested for numerous diseases after it is donated to ensure a safe blood supply for patients.

So why doesn't everyone who is eligible give blood?

That is perhaps the best question of all. Many people would answer "fear". There are a lot of misconceptions regarding the health safety of giving blood. You absolutely cannot "catch" a disease from giving blood. All equipment is sterile, new to each donor, and one-time use. Additionally folks are afraid of needles. While that is valid, as one does need to be "poked" to access a vein for blood donation, the staff are trained phlebotomists: a medical professional who is trained to perform blood draws. It's their specialty and it's all they do! Additionally, the initial "poke" from the needle takes literally one second! One second to save a life!

As a nurse on an acute care floor, I encourage you to consider giving blood, especially you O+/- folks!! Blood saves lives and there is no substitute. We live 10 minutes form our local hospital and the entire process takes ~30 minutes (platelet donation takes longer). Additionally, you can host the "Blood Mobil" at your place of employment. The "Blood Mobil" is a mobil blood donation center/bus that can set up shop just about anywhere! LHAAMC relies solely on volunteer donors and maintains its own "blood bank" locally. Plus, you get free snacks, swag, and bragging rights after donating! I cannot stress this enough:

Get out there Cape - DONATE!!

Successful Spring Planting

On May 4th Cape Conservation Corps spent the day planting over 1000 native plant landscape plugs at Little Magothy Beach park along the slope to the right of the driveway. We had spent three previous Weed Warrior Days removing the invasive plants growing along there, including the horrible day lilies or "ditch" lilies, liriope, dames' rocket (aka money plant), euonymus, English Ivy, and a host of other harmful plants.

We replaced them with several natives, Phlox divacarta woodland phlox, Solidago caesis golden rod and Carex woodie. These plants will not only create a healthier ecosystem, increase biodiversity but will help control erosion and runoff. Native plants have spent thousands of years co-evolving with native fauna of the area, supporting life, and helping them complete their life cycles.

We had 27 total volunteers (including 16 kids from the high school) work 61 hours in the rain. In addition to 1000+ plugs we also planted 25 shrubs, 25 mayapples and 25 quarts of assorted golden rod and asters.

In the fall we will be planting 45-50 trees and shrubs in the wooded area of the Little Magothy Beach property as well as adding some to Serene Ravine. We will continue working all summer into October on invasive species removal and would love to have some more folks join us. On the job training!

Our next events are listed at the top, including the Strawberry Festival. We have over 150 milkweed seedlings available for the kids to pot up into a homemade newspaper pot and take home to support the monarch butterflies. Stop by our table and learn more about CCC and all the programs we have.



2024 CAPE CLEAN-UP

Anne Arundel County Waste Management has graciously offered Cape Residents 3 days in June for our 2024 Clean-Up. The Clean-Up will begin as soon as the County arrives on Wednesday (before Noon). We will make every effort to operate the Clean-Up until 4:00 PM, space permitting. On Thursday the Clean-up will begin at 7:30 AM and continue until approximately 4:00 PM, space permitting. On Friday the Clean-up will begin at 7:30 AM and continue to approximately 12 noon. In an effort to protect our environment and dispose of our trash properly, Anne Arundel County will be providing the clean-up with cans for recycling and 2 on-site Anne Arundel County Employees to assist the residents with the proper disposal of their TRASH. When you arrive at the clean-up you will be asked to dispose of your TRASH in the proper cans. Please keep this in mind as you load your vehicles. Try to keep your recyclables together (Cardboard, Paper, Metals etc...)

CSCIA Beaches and Parks Rules and Regulations

- 1. Beaches, parks and the boat ramp at Deep Creek are only for the use of property owners current in the payment of their maintenance fees, and their accompanied guests. Guest passes cannot be used for the launching ramp at Deep Creek Fridays through Sundays. Guest passes may be used for vehicles without trailers at Deep Creek during all regular park hours.
- 2. All Cape St. Claire beaches and parks will be closed to everyone from 10 p.m. to 6 a.m. Violators will be subject to prosecution under the Maryland Trespass Law, Annotated Code of Maryland, Article 6-402/6-403. Conviction under this law may involve a fine of not more than \$500 or a 3 month imprisonment, or both.
- 3. Vehicles parked on community property must display their current assigned Cape St. Claire bumper sticker on the rear of their vehicle, or a guest pass hanging from the rear view mirror, or a temporary parking permit (issued for special events held at the clubhouse and approved, reserved beach parties) inside the front windshield on the driver's side. Any unauthorized vehicles will be towed at the owner's expense.
- **4.** No loitering is allowed in the community parking areas.
- 5. No motorized vehicles are allowed on the beaches and no boats are allowed on the beaches or anchored at the beach waterline. This includes golf carts, motorized scooters or other On Road Vehicles (ORV.) ORVs may be parked on community owned parking lots with valid parking passes.
- **6.** Windsurfing is permitted outside of the designated swim area only.
- 7. Consumption of alcoholic beverages IS NOT permitted on the beaches, in the parks, or in the community parking lots. Glass containers are not permitted at our beaches.
- **8.** Dogs on community property shall be on a leash and within their owner's control at all times. Dog owners must clean up their dog's waste. Bags are provided at the beaches for your convenience.
- 9. No commercial use of the piers, beaches or parks is allowed
- 10. The use of piers is limited to slip renters. Fishing and crabbing from the community piers continues to be prohibited, except from the fishing and crabbing pier at Lake Claire. Residents are also reminded that the boat piers are totally maintained and paid for by slip renters.
- **11.** Dumpsters on community property are for the use of people using these facilities, not for household refuse.
- **12.** Permission for social gatherings of 20 or more people at the beaches and parks must be requested in writing from the CSCIA Beaches and Parks Committee, and the appropriate permission form must be completed and signed by the sponsor(s). Social gatherings of more than 30 people will need special permission from the Beaches and Parks committee chair.
- 13. Violators of these policies may be banned from CSCIA properties and trespassers will be prosecuted.


