Board In Brief CSCIA Board Of Governors Monthly Meeting

NOVEMBER 11, 2024

Pres. Zadera called the meeting to order at 7:30 pm. He recognized Veterans Day and thanked veterans for providing the freedoms we enjoy. This is the biggest turnout at a meeting he has attended- he thanked all for being involved.

MINUTES AND FINANCIAL STATEMENTS

Minutes of the Oct 14, 2024, Board of Governors (BOG) meeting were reviewed. A motion to accept the minutes was made. Gov.Breeden noted in New Business—Fairwinds Marina is zoned "MB", not "Marina B" and the meeting with Fairwinds owners also included Wayne Newton of Messick & Associates engineering firm. With those changes, the motion passed unanimously.

The financial statements for Sep 2024 were reviewed. A motion was made to approve. Balances of the bank accounts are approximately: Operating funds- \$203,000 Beach restoration grants- \$165,000, piers- \$293,000 and Special Community Benefits District (SCBD)- \$100,000. The motion passed unanimously.

TOWN MANAGER REPORT

Mr. Tewey reported on the following: The water heater in the clubhouse was replaced. The Little Magothy River Association (LMRA) annual meeting is scheduled for Nov. 20. He has received 61 emails regarding Fairwinds development and the majority are opposed to it.

The proposed Fiscal Year 26 (FY26) budget approved by the board was published in the Nov. issue of The Caper. The audit for FY24 was submitted to the county and the FY26 SCBD budget is due by January 31, 2025.

Police officers are covering 16 of 30 dates in Nov. Crime reports included 2 assaults, 3 thefts, 2 mental health issues, 1 weapons violation and 1 found property. It was noted that these reports include some nearby neighborhoods, the shopping center and schools, that there is no noticeable trend or perceived security issues. Please lock your homes, boats and cars and keep valuables out of sight.

Letters were sent to inform homeowners adjacent to the clubhouse field of a new fence to be installed to replace the wooden one. Replies are due by December 1.

A Broadneck High School student was granted permission for a beach cleanup day on Jan 11, 2025, by the Surfrider Club. The combination lock on the Lake Claire boat pier gate was repaired. The piers committee will decide if a different type of lock is needed.

A county administrative board hearing for a variance to allow an addition (approved by CSCIA) with less setback and buffer than required is Nov. 26. A hearing for a deck with less setbacks and buffer is Dec 5. No application was submitted to CSCIA and Mr. Tewey made the homeowners aware of the requirements. One standard building application was approved. One request for a replacement in kind dock was received and a pier agreement drafted by the attorney and sent to the homeowners. A complaint was received about a shed being built without permits. No county permit is filed, a stop work order posted, and no application received by CSCIA.

COMMITTEE REPORTS

Broadneck Council of Communities (BCC): Gov. Breeden reported that the BCC meeting in Sep included the State Highway Admin findings on the Route 50 traffic study. Plans for 2025 are expected about April. The Jan quarterly meeting will include state delegates.

Beaches & Parks: Gov. Breeden announced another \$75,000 grant from National Fish & Wildlife Foundation awarded for design of shoreline restoration at sites 3-7. Pres. Zadera, Gov. Breeden and Town Manager Tewey met with Alliance for the Chesapeake to work on the proposal for a Chesapeake Bay Trust grant. LMRA was awarded a grant to dredge the Little Magothy. CSCIA is working to obtain about 6,000 yd³ of sand to add to the main beach and to create an in-water sand dune at Lake Claire. The analysis has cost \$43,000 and the permit application will be submitted soon. The LMRA grant would pay for construction. Mr. Tewey added that regarding grants for construction, success at Lake Claire with previous grant funds, plus having complete designs, makes it appealing for follow-up grants.

Caper: Gov. Lamb said the Nov. issue was in mailboxes last week, articles for the Dec/Jan double issue are due Nov.15.

Clubhouse: Gov. Lamb mentioned the water heater replacement and noted that weekend rentals are almost full for 2024.

Events: Gov. Lamb announced a movie night, showing Elf, and sponsored by 'Til Next Time, on Nov. 26. The Tree Lighting is Dec 1 at the guard shack. Breakfast With Santa will be Dec 14.

CAPE ST. CLAIRE IMPROVEMENT ASSOCIATION Budget, Assessment and Cap

Each year the Cape St. Claire Improvement Association, Inc. (CSCIA) Budget Committee develops a proposed consolidated budget for the community. The Committee is composed of three at-large members elected by the community and two members appointed by the Board of Governors ("the Board").

The Budget Committee is tasked with preparing the overall budget of the community and presenting it to the Board for review, comment, modification, and recommendation. Once finalized, the proposed budget is presented at the annual January membership meeting. Input from Community members is always welcome and important. Membership can vote to approve, modify, reject, or do nothing with the proposed budget.

The Board has reviewed the draft budget as presented by the Budget Committee and recommends adoption of the enclosed consolidated fiscal year 2026 (FY26) budget by its membership at the January 2025 annual membership meeting. The Budget Committee appreciates the input and insight received from President Zadera, Treasurer Lamb, Board Members, and our Town Manager in formulating the proposed budget.

The budget summary includes three budget components: the Cape Special Community Benefit District ("SCBD") budget, the CSCIA Maintenance budget and the CSCIA Piers budget. Although not required, the Maintenance and Piers budgets are presented jointly along with the SCBD budget as a best practice and for transparency.

SCBD revenue is collected, appropriated, and remitted to CSCIA from the County through annual property tax bills. The County retains an annual \$2,000 processing fee and ensures annual repayments for any current and outstanding loans owed by CSCIA. SCBD funds are used in strict adherence to applicable statutes, as ratified by the community.

Non-SCBD revenue includes yearly maintenance fees, <u>The Caper</u> advertising, clubhouse rentals, slip rentals, and other miscellaneous sources and fees. Miscellaneous sources may include grants or cash from savings.

The consolidated budget spreadsheet contains SCBD and non-SCBD projected revenues and expenses, and their respective line-item totals. For comparison purposes, separate columns show *actual* FY23 and FY24 figures and the *approved* FY25 budget figures. The FY26 budget includes the scheduled mandatory Capital Reserve Funding requirement. A statutory annual contribution of \$131,359.00 is required to be made in FY26.

The current SCBD assessment cap is \$300 per tax account. Based on the 2,292 assessed Cape St. Claire SCBD tax accounts, the Board and the Budget Committee recommends increasing the <u>annual assessment</u> from \$270 to \$283 for FY26, a \$13 or 4.81% increase. **Note:** The SCBD assessment cap can only be increased by the membership every two years. The last increase was approved in the FY25 budget, so the Board and the Budget Committee recommends maintaining the assessment cap at \$300 for this budget year.

The Budget Committee and Board worked diligently to limit any assessment increase by finding savings, addressing cost increases, and setting priorities, while maintaining service levels and funding the repayment of loans for the Shoreline Restoration Projects. The overall proposed FY26 budget, less mandatory funding for the Capital Reserve Fund, reflects similar budgets of the past. **The Board and the Budget Committee recommend adopting the proposed budget.**

Please plan to attend the January 2025 CSCIA membership meeting to vote on the proposed budget. Your vote for or against the consolidated SCBD and Non-SCBD budget will be by ballot and for your convenience, a ballot will be enclosed in The Caper's December/January issue.

If the members do not approve the proposed FY26 budget, CSCIA Bylaws and SCBD regulations require the CSCIA to operate under the previous year's approved budget. This would assuredly result in the underfunding of the CSCIA in FY26 and jeopardize the ability of the CSCIA to purchase goods, provide services, perform maintenance on community assets, and place the CSCIA in violation of the law by not completely funding the required Capital Reserve Fund.

BACKGROUND: A Special Community Benefits District (SCBD) provides revenue through assessment to fund community approved services for the purpose of:

Board In Brief CONTINUED

Piers: Gov. Breeden announced renewal/warning letters will go out to slip holders and the waitlist updated. Estimates received for replacement of pier sections at Deep Creek range from \$298,000-600,000. Savings for the project are available, and the project might be done in phases. A resident asked if a dredge there could be carried out at the same time. Gov. Breeden said that it could be investigated. The original expected cost was \$70,000 and the remediation project approved. The replacement of the piers will not be delayed for a dredge.

Strawberry Festival: Planning is ongoing. Volunteers are always needed!

NEW BUSINESS

Pres. Zadera gave an overview of what has occurred regarding Fairwinds Marina. CSCIA was made aware that owners were investigating the possibility of creating a new 30–50-unit retirement community of townhomes/condominiums. Several governors met informally with the owners, Larry Goldberg and his daughter Joanna, and with Wayne Newton of Messick & Associates engineers. At this point there are no formal proposals, and several issues such as critical area, density, utilities, and current zoning. It was discussed at the BOG meeting, and at the quarterly CSCIA meeting where a motion was made and passed to not support a change to the MB zoning to allow for residential housing. Gov. Breeden gave more details, reiterating that there is only a concept and no formal plan. With the current zoning, Fairwinds can have a marina, boat sales and repairs, a boatel (multilevel boat storage), hotel, clubhouse, pool or restaurant, but not residential housing. That would require a textual amendment to the zoning, not a change of zoning. It would be a legislative process in which a member of the County Council would present it, research would be done, it would have to pass by at least 4 to 3 in favor, and then be signed by the County Executive. It would be a long process. The BOG will collect information and questions to ask, get feedback, and determine if the community supports the idea. Mr. Tewey asked that everyone please avoid rumors and get the facts.

COMMENTS

Much discussion followed with several residents of Cape St Claire, Atlantis and Bay Head speaking out. Concerns were mainly about traffic, pedestrian safety, city water scarcity, runoff, erosion, and other ecological concerns, access to Cape amenities, affordability, potential for the 55+ restriction to be dropped, overcrowding of schools, etc. Many questions were asked and Governor Breeden answered those he could, and said many others are good questions for the BOG to take back to the county council. Others were not answerable because there is no proposal, textual amendment request, or applications yet. Textual amendments would be county-wide, not just Fairwinds. Zoning designations have permitted uses, conditional uses, and special exceptions, which all go through different processes. It is unknown if similar situations have occurred in the state or county but when that question is asked, it must be for properties with the same zoning designation. If the idea is pursued, traffic studies, environmental impact studies, ownership research, etc., would occur. Traffic studies have typically estimated 10 trips per day per unit. There are still about 200 buildable lots in Cape. Fairwinds is private property, not part of the deeded Cape plats, though they do pay an SCBD fee. Cape St Claire bylaws only allow single family dwellings. Area schools are not at capacity so there is no moratorium on building. Any deed restrictions would have to be written into the contracts. There is a legal process to gain an easement to allow for utility connections and a previous request from the Goldbergs to allow for sewer connection across the entrance to Lake Claire was denied by CSCIA. The Goldbergs would continue to operate the marina and would add something. There will be some change, if not housing then something that the current zoning allows (see New Business above). Gov. Breeden said that the first step is to speak out and he noted that the Goldbergs could have gone further with plans before discussing with CSCIA. How public opinion affects offices such as OPZ, which has laws to follow, is different than how it may affect people such as council members and the executive. There would be several opportunities for public comments because of the various issues involved. One resident who was on the advisory board for the recent rezoning saw issues from all sides, and the ripple effect of decisions. She said public comments go a long way, and the number of people who speak out matters. Town Manager Tewey added that people should speak for themselves instead of counting on others to do so. Several people asked how the communities could work with Goldberg's to find an endeavor that would benefit Fairwinds and be less offensive to neighbors. One resident spoke about the lack of housing in Maryland and how no one wants development in "their backyard" but wants houses available for their children to purchase. Another spoke of the options available to Goldberg's currently, some of them could be worse than housing. It was suggested that a survey be organized to see what the community would support. Public meetings would be necessary for several steps in this type of activity and the board is in conversation with the county to get information to make available to the public. Gov. Breeden suggested that a petition be created to start the process of measuring public opinion in support of or against. He asked that the board be given time to organize feedback. A straw poll was taken with one in support of the development, two abstentions, and the remainder of the attendees were opposed. Wayne Newton, land development consultant for Messick and Associates, thanked the board for explaining the concept and having conversation. He presumed that Mr. Goldberg would continue to live at the property and thought a 55+ community would fit best with Cape St Claire. Mr. Newton will discuss the reaction of the community with Mr. Goldberg.

Becky Benner announced the Garden Club meeting on Nov 12 and the Dec 2 event to make wreaths for the office, guard shack, & library.

Mrs. Benner reported the Critical Area Commission has approved use of Goshen Farm property for mitigation for the construction of the new fire house. Several acres overrun by invasive species will be partially clearcut and planted with native plants. A concerted effort will be made to save native trees and trees must be monitored for 10 years. She commended Roy Benner for his deep research to make the plan happen. Goshen Farm Goodies, items made from produce harvested from the farm, will be available on Nov. 30.

Brad Knopf of Cape Conservation Corps (CCC) reported native species obtained by grant funding were planted by volunteers at Little Magothy Beach. He thanked Brian Smack and Cliff Dean for allowing use of their water. Paths at Little Magothy Beach and the Serene Ravine were mulched. The Nov. 15 meeting will feature speaker George Mauer and a book signing by Ellen Prager and Dave Jones. There will be a silent auction of artwork done by residents of the Cape. An "open house" celebration for The Little Learning Libraries is Nov. 16.

ADJOURNMENT

A motion was made to adjourn to closed session and approved unanimously. The meeting was adjourned to closed session at 8:58 pm. The Nov. 11, 2024 CSCIA Board of Govs. meeting was adjourned at 9:42 pm.







The CCC is so passionate about trees that we are starting a new initiative, a free tree planting program. Applicants will be given free native trees to plant on their property. We will help you choose what's best for your particular space and even help you plant it!

So...Leave the Leaves and Plant More Trees!

Cape Loves Trees More trees please and leave the leaves.

As we enjoy this incredible fall weather I am reminded of the gift that is the perfect autumn day. We are so fortunate in the Cape. A short walk invites us to marvel at the season's splendor. The brilliant transition of our local trees as they give way to an ever-changing palette. Among the first are the black gums with bright reds deepening to purple, then the maples flaming bright - reds, oranges and yellow, tulip trees are next - grand and stately yellow and finally the oaks — muted reds and spent brown. We wait in frustration to finish our raking chores as some of the oaks in their marcescence hold their leaves, some stingily clinging till spring, just as we hold onto the last warm days as they slip away towards winter.

One landscape maintenance practice that we can add to our stewardship efforts is to leave the leaves from our trees. In our natural forested ecosystems the forest floor is covered in leaves. They act as a mulch, insulating the soil and preventing erosion. As they decompose they add nutrients to the soil. Finally, they provide much needed habitat to smaller critters like amphibians and beneficial insects. We may not all have a forested yard where we can leave the leaves for their natural purpose, but we can try to keep as many on site as possible. Shredding leaves and adding them to existing garden beds or composting them with other organics such as our garden scraps for use as a soil amendment in the future. All of these practices can help our environment and reduce the carbon used to transport and process them off-site.

We hope you had the opportunity to get out and enjoy this fall, spending time outdoors with your family and friends, amongst the trees in all their glory. Perhaps, one last outing on the water. Paddling the wooded edges of a cove on the Little Magothy, the osprey have moved on, replaced by the sound of geese overhead. The reflection of autumn leaves on the water reminds me that our beloved Chesapeake evolved amongst a forested watershed. Let's not take what we have for granted. We need our trees for a livable community, our health and the health of the Bay.

Continue to celebrate the trees we love by visiting some of the Cape's remarkable specimens. The Cape Loves Trees initiative of the CCC was started by documenting many trees that our community considered special. You can find that list on our website:
